The Veteran's Affairs Committee (VAC) of Elks Lodge ~ 2679 in Calabash, NC, recently donated \$1,000.00 in WalMart Gift Cards to the Fisher House located near the U.S. Naval Hospital and Wounded Warrior Complex at Camp Lejeune in Jacksonville, NC.

A "Fisher House" is "a home away from home" for families of patients receiving medical care at Major Military and Veteran's Administration (VA) Medical Centers, in this case, the Naval hospital at Camp Lejeune. The homes are normally located within walking distance of the treatment facility or have transportation available. There are no other facilities on military installations that provide this caring, compassionate environment. Fisher Houses do not receive tax money or military dollars. Charitable contributions provide the majority of their funding. There are 70 Fisher Houses located on 24 military installations and 27 VA Medical Centers around the country.
